BY THE VILLAGE OF HOBART

Village as follows:

Section 1: The Village of Hobart shall contain on and after the effective date of this Local Law, in addition to the territory previously contained within its boundaries, the following described territory:

"ALL THAT TRACT OR PARCEL OF LAND situate, lying and being in the Town of Stamford, County of Delaware and State of New York, being bounded and described as follows: COMMENCING at a point on the northeasterly boundary of the lands of the County of Delaware Industrial Development Agency marked by an iron pin; thence N 52° 52' 00" E 101.62 feet along the lands of said Agency and along the corporation line of the Village Hobart to an iron pipe set in the ground; thence continuing along the lands of said Agency and the line of said Village S 52° 27' 30" E 317.50 feet to a 24-inch maple tree on the northerly boundary of the lands of Murphy (553/630); thence along the lands of said Murphy and lands of Oakley (547/573) S 87° 06' 06" E 379.33 feet to an iron pin; thence continuing along the lands of said Oakley N 76° 31' 12" E 340.06 feet to an iron pin set on the westerly boundary of the lands of Murphy (458/832); thence N 00° 55' 45" E 382.90 feet to a point; thence N 53° 35' 35" W 1073.50 feet to and along the southwesterly boundary of Lot No. 270 to a point on the corporation line of the Village of Hobart; thence S 27° 59' 30" W 496.98 feet along said corporation line to a point; thence S 58° 34' 00" E 79.20 feet along said corporation line to a point; thence S 01° 00' 30" E 364.32 feet along said corporation line to the point or place of beginning, containing 17.746 acres of land.

Section 2: The territory described in Section 1 of this Local Law is hereby annexed to the Village of Hobart pursuant to Section 114 of the General Municipal Law.

Section 3: The annexation of the above territory described in Section 1 of this Local Law shall become effective on the 30th day of April, 1980.

Section 4: This Local Law shall take effect immediately.
